The KAREEBERG MUNICIPALITY invites tenderers from civil engineering contractors for the upgrading of **Botterblom Crescent** in VanWyksvlei. The works will include the construction of road layer works with a paved concrete road surface and stormwater channels.

Only those tenderers who are actively registered with the CIDB, in a contractor grading designation equal to or higher than the latest CIDB promulgated contractor grading designation, determined in accordance with the sum tendered will be eligible to tender. The project is estimated that the contractor grading designation could be **4 CE** or higher. Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders.

The Kareeberg Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy framework Act, Act No 5 of 2000 and the regulations promulgated under this act shall apply in the adjudication and awarding of the tender.

Postal delivery to reach Kareeberg Municipality, Private Bag X226, Carnarvon, 8925, not later than 12h00 on 11 April 2019, after which the tenders will be opened in public. Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted and incomplete tenders and tenders received late will not be considered. Take note that any reference to tender closing dates referring to 4 April 2019 within the tender document must be replaced with 11 April 2019.

Tenders may only be submitted on the tender documentation downloaded from the website and Tenderers are required to print, complete and bind hard copies for submitting the tender.

The Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or only part of the tender if; (a) the tender-amounts received are too high; (b) the tenderers do not comply with the specific tender goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any tenders. The 80/20 preference point scoring system will be used for the tenders.
