The following terms and conditions will apply.

- Certified copy of Municipal Account not older than 90 days or Lease Agreement. Municipal Accounts must be up to date.
- NT CSD registration is compulsory. Bidders are expected to include their latest CSD printouts with their bid proposal.
- SARS Tax clearance certificates or SARS Tax Pins must be provided. Failure to include this documentation or Pins will lead to automatic non-reponsiveness.
- The price quotation is expected to be within a threshold of **R 30 000 and R300 000** incl VAT.
- For this purpose, the enclosed Price Schedule must outline the different functional areas clearly.
- This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in Preferential Policy Framework Act ( No. 5 of 2000) and; **where 20 points will be divided in to 10 points for BBBEE Contributor Level and 10 for Locality. Locality is subdivided into 7 points for entities who'se official registration address is with Kareeberg Municipal Area and 3 points Northern Cape.**
- The successful provider will be the one scoring the highest point and will not be always the lowest bidder
- The bid is subject to regulation 5 of the Preferential Procurement Regulations as amended.
- All the relevant MDB 4, 6, 8 and 9 documentation must accompany your bid proposal
- Original or certified BBB-EE Contributor Level Status documentation must be included in the bid proposal. Omission will score zero points.
